# 2024 ADULT QUALIFYING COMPETITION SEASON

#### **TECHNICAL ANNOUNCEMENT**

#### **GENERAL**

The 2024 U.S. Figure Skating adult qualifying competition season consists of four events - three qualifying events (adult sectional championships) and the 2024 U.S. Adult Figure Skating Championships. All four events are sanctioned by U.S. Figure Skating and conducted according to the 2023-2024 U.S. Figure Skating Rulebook with changes and clarifications as posted on the U.S. Figure Skating website and this announcement. Compliance with these rules as updated or amended is the responsibility of the participants. U.S. Figure Skating reserves the right to incorporate revisions to the international judging system (IJS) made by the ISU.

Adult sectional championships and U.S. Adult Figure Skating Championships events are open only to current members of U.S. Figure Skating who meet the eligibility requirements in U.S. Figure Skating rule 2210, all age and test requirements pertaining to the event they are entering, and the citizen and residency requirements as stated in rule 2240.

Non-U.S. citizens who have already received a letter of permission from the Chair of the Competitions Committee and were accepted to compete in the U.S. Figure Skating qualifying system are eligible to register. All other non-U.S. citizens seeking eligibility must meet the requirements set forth in rules 2240 and 2212.

#### **Coaches at U.S. Figure Skating Qualifying Competitions**

To be a credentialed coach at a U.S. Figure Skating qualifying competition, a professional coach or choreographer must meet the requirements from rule 1310.

Each local organizing committee (LOC) will be provided access via U.S. Figure Skating's Event Management System (EMS) to verify coach compliance. Coaches will need to check in at the event registration desk and show a government issued photo I.D. to receive a credential. Coaches who are NOT compliant at time of check-in will need to show proof of any/all missing compliance items prior to being accredited. If a coach cannot provide the necessary documents, they will not be allowed a credential – no exceptions.

#### **EVENTS**

#### ADULT SECTIONAL CHAMPIONSHIPS

The adult sectional championships consist of the following qualifying championship events: championship masters junior-senior free skate, championship masters intermediate-novice free skate, championship adult gold free skate, championship adult silver free skate, championship masters pairs and championship adult partnered dance.

All other events offered at the adult sectional championships are considered nonqualifying and offered at the discretion of the Local Organizing Committee. Adult Competition Series final events are also a part of the nonqualifying competitions held in conjunction with the adult sectional championships. Please refer to the nonqualifying competition section of each specific adult sectional competition announcement for the nonqualifying events being offered.

#### **U.S. ADULT CHAMPIONSHIPS**

The U.S. Adult Figure Skating Championships shall consist of the following events (See rule 2055 and amendments in Technical Notification 271): \*\*\*\*\*\*

- **A. Events that require qualification from sectionals:** championship masters junior-senior free skate, championship masters intermediate-novice free skate, championship adult gold free skate, championship adult silver free skate, championship masters pairs, championship adult dance and championship adult solo dance.
- B. Events that do not require qualification from sectionals ("NONQUALIFYING"):
  - 1. Free skate: masters junior-senior free skate, masters intermediate-novice free skate, adult gold free skate, adult silver free skate and adult bronze free skate.
  - 2. Pairs: masters pairs, adult gold pairs, adult silver pairs, adult bronze pairs and centennial pairs.
  - 3. Partnered dance: masters open partnered pattern dance, adult gold partnered pattern dance, adult pre-gold partnered pattern dance, adult silver partnered pattern dance, adult

- pre-silver partnered pattern dance, adult bronze partnered pattern dance, adult pre-bronze partnered pattern dance, centennial partnered pattern dance, masters open partnered free dance, adult gold partnered free dance and adult pre-gold partnered free dance.
- 4. Solo dance: adult gold solo pattern dance, adult pre-gold solo pattern dance, adult silver solo pattern dance, adult pre-silver solo pattern dance, adult bronze solo pattern dance, adult gold solo free dance, adult silver solo free dance and adult bronze solo free dance.
- 5. Showcase: masters emotional performance, masters lyrical pop/character/comedy, adult gold emotional performance, adult gold lyrical pop/character/comedy, adult silver emotional performance, adult silver lyrical pop/character/comedy, adult bronze emotional performance and adult bronze lyrical pop/character/comedy.

Skaters may enter a maximum of four events, including championship events. If qualifying for championship events puts a skater over the four-event limit, the skater may withdraw from the event of his/her choice without financial penalty.

RECENT CHANGES TO EVENTS (please refer to the 2023-2024 U.S. Figure Skating Rulebook; this is not an all-inclusive list of changes):

**Bronze Singles/Bronze Pairs:** Per rule 1041, adult bronze singles will be judged using the IJS system at both the adult championships and the non-qualifying events held in conjunction with the adult sectional championships. Adult bronze pairs will be judged using the IJS system only at the adult championships.

Championship Masters Pairs, Masters Pairs and Adult Gold Pairs: Per rules 7511, 7521 and 7531, jump combination or sequence may consist of two or three jumps.

**Adult Pre-Silver Solo Free Dance and Adult Pre-Gold Solo Free Dance:** Per rules 8710 and 8730, these levels of adult solo free dance have been added. Please read all test levels to ensure you enter the correct level as your level may have changed since the 2023 season.

**Fall Deduction for Bronze and Silver:** Per rule 1071C, the fall deduction is now .25 for adult bronze and adult silver.

**Solo Pattern Dance Steps:** Per rules 8631 (B), 8641 (B), 8651 (B), 8661 (B), 8671 (B), 8681 (B) (pages 287-288, Rulebook), Events will not be separated by gender. Skaters may choose to perform either the follow steps or the lead steps.

**Singles Eligibility Rule Update:** Per rule 6500, any skater who has competed in the U.S. Figure Skating Championships, the ISU World Figure Skating Championships, the ISU World Junior Figure Skating

Championships, an ISU Grand Prix event, an ISU Junior Grand Prix event, an ISU Challenger Series event or the Olympic Winter Games in novice singles, junior singles, or senior singles: 1. May not compete in the adult gold, adult silver or adult bronze singles events. 2. May compete in the masters intermediate-novice and masters junior-senior singles events. The update and TN301 went into effect on December 1, 2023.

#### **REMINDERS OF PAST CHANGES:**

**Championship Adult Solo Dance:** Per the Board of Directors meeting November 5, 2022, this event has been added. The update and TN289 went into effect on December 1, 2022.

The governing rules are 8630-8632, 1041, 2055, 2401, 2405, and 8082.

For 2023-2024 the pattern dance is Argentine tango. The free dance is 2:40 +/- 10 seconds and is to be skated in accordance with the rules for the adult gold solo free dance event.

**SHOWCASE:** Wearable Inflatable costumes are not permitted in the Emotional Performance or Lyrical Pop/Character/Comedy events at the U.S. Adult Figure Skating Championships or at the nonqualifying competitions held in conjunction with Eastern, Midwestern and Pacific Coast Adult Sectionals. If a skater performs with a wearable inflatable costume in any aforementioned event, the skater may be disqualified. Please refer to the 2023-2024 Showcase Guidelines for more details.

Championship Adult Free Dance, Pre-Gold Free Dance, Gold Free Dance, Masters Open Free Dance: Per Rule 8512, one choreographic element is required.

Adult Gold Solo Free Dance & Championship Adult Solo Dance (free dance portion): Per Rule 8701, only one twizzle series is required.

**New rules for qualifying rounds:** Per Rule 2551, there are updated rules for qualifying rounds at the Adult Championships.

#### SPECIAL AWARDS/TROPHIES:

**Club Awards:** Per TMR 6.01, there will be club awards at the U.S. Adult Championships. Two club awards will be given, based on the number of home club members registered with U.S. Figure Skating as of the prior season's published Membership Report: a Large Club Team Award (for clubs with 175 or more members) and a Small Club Team Award (for clubs with less than 175 members).

Lifetime Competitor Recognition Program: The U.S. Adult Figure Skating Lifetime Competitor Recognition Program recognizes competitive adult figure skaters who have successfully demonstrated longevity in the sport through their ongoing participation in the U.S. Adult Championships and/or Adult Competition Series. It defines the ultimate success in competitive adult figure skating as being physically able to skate competitively for a lifetime and rewards competitive adult figure skaters who manage their training in a way that makes this possible. The U.S. Adult Figure Skating Championships Lifetime Competitor Recognition Program is open to all members of U.S. Figure Skating and Learn to Skate USA who compete at the U.S. Adult Championships and/or in the Adult Competition Series. Additional details on the recognition program are available here. Athletes must register to participate in the recognition program here.

Skate Forever Young Awards: U.S. Adult Championships Skate Forever Young Awards are medal-like

awards given to all competitors who are 71 and older for their participation at the U.S. Adult Championships and the Adult Competition Series. Three levels of awards are available, based solely on age as of the close of entries (Feb. 1, 2023):

71 years to 75 years of age
 76 years to 80 years of age
 81 years and older
 Bronze Skate Forever Young Award
 Silver Skate Forever Young Award
 Gold Skate Forever Young Award

**Adult Special Achievement Awards:** U.S. Figure Skating Adult Special Achievement Awards are pins given to adult athletes in IJS-judged qualifying events to encourage and reward high-quality elements, performances, and skating. Pins are awarded in championship singles events at the adult sectional championships and championship pairs and dance events at the U.S. Adult Championships. Click here for more details (scroll down to "Competitive Opportunities").

**Yvonne M. Dowlen Trophy:** The Yvonne M. Dowlen Trophy will be awarded annually to the oldest registered competitor who competes in an event at the U.S. Adult Figure Skating Championships. A competitor is permitted to receive this award once every three years. If a competitor has won in the previous two years, then the next-oldest eligible competitor will be that year's recipient.

#### ONLINE REGISTRATION (OPENS December 18, 2023)

#### A. METHOD

Online registration via EMS at <u>www.usfsaonline.org</u> is the ONLY method available for entry into ALL events (qualifying and nonqualifying) at the adult sectional championships and the 2023 U.S. Adult Figure Skating Championships.

- Select the "competition registration" tab
- Find your competition under Qualifying Competitions and click "Register"

#### **B. DEADLINES**

The entry deadline for the 2024 Adult Qualifying Season (sectionals and championships) is 11:59 p.m., February 1, 2024. NO REGISTRATIONS WILL BE ACCEPTED AFTER THIS DEADLINE. NO EXCEPTIONS.

Age requirements for the U.S. Adult Championships and adult sectional championships must be met by **February 1, 2024**.

Test requirements must also be met by **February 1, 2024.** Provisional entries based on passing a test after the closing date of entries will not be accepted. Please refer to U.S. Figure Skating rules 2422

and 2423 for further testing information and guidelines. Skaters may NOT "skate up". Skaters may NOT test the next higher level after the close of entries.

#### C. ELIGIBILITY

This event is open for participation to all eligible competitors who are members in good standing of U.S. Figure Skating per rule 2212.

For **championship** events at the U.S. Adult Championships and adult sectional championships, non-U.S. citizens who have represented a foreign federation at any level of skating competition must meet the requirements of rule 2243. "Non-U.S. Citizen Application to Compete" and supporting documentation must be submitted to the Chair of the Competitions Committee no later than January 25, 2023. Forms are available on <a href="https://www.usfsaonline.org">www.usfsaonline.org</a> within step one of registration. Non-U.S. citizens who have never represented a foreign federation at any level of skating competition may enter championship events if qualified by test level. It is not necessary to complete the "Non-U.S. Citizen Application to Compete".

Those entering **nonqualifying** events at adult sectionals and the U.S. Adult Championships are not subject to rule 2241, but fall under rule 2212, which states that they must be legal residents of the U.S. and meet all other test, age and membership qualifications. Non-U.S. citizens entering nonqualifying events need only fill in the appropriate boxes on the nonqualifying entry form.

Skaters may not enter a championship event at an adult-track qualifying competition (adult sectionals/U.S. Adult Championships) and a qualifying event at a standard -track qualifying competition (regionals/sectionals/U.S. Championships) in the same kind of event, in the same competition season. For example, a skater may not enter novice men's free skate at a standard-track qualifying competition and championship masters intermediate-novice men's free skate at a standard-track qualifying competition in the same season. However, a skater may enter novice men's free skate at a standard-track qualifying competition and masters intermediate-novice men's free skate (not a championship event) or championship masters pairs (different category) at an adult-track qualifying competition in the same season.

Age and <u>test qualifications</u> as of entry deadline date will determine event eligibility and classification for all. Tests passed after close of entries and prior to the event will disqualify skaters if test exceeds maximum requirement for the event entered in this competition.

Skaters may compete in as many disciplines as qualified by test level but may compete in only one event per discipline with maximum total of four events. As an exception, a competitor who qualifies to enter a championship event through their adult sectional championships may also enter a nonqualifying event in the same discipline so long as they do not exceed the four-event limit. Competitors are permitted to enter both emotional performance and lyrical pop/character/comedy events. Competitors are permitted to enter both pattern and free dance events. Competitors are not permitted to enter centennial partnered pattern dance events if they are also competing in another nonqualifying-level of partnered pattern dance (even if with another partner) and vice-versa. Competitors are not permitted to enter centennial pairs events if they are also competing in another nonqualifying-level of pairs (even if with another partner) and vice-versa.

A judge, referee or accountant assigned to the U.S. Adult Figure Skating Championships may not skate as a competitor in any event of the competition, qualifying or nonqualifying. A judge, referee, or accountant invited to an adult sectional championship may compete in the nonqualifying competition held in conjunction with the same adult sectional championships. A judge, referee or accountant invited to serve at the nonqualifying competition held in conjunction

with an adult sectional championships may compete in a championship event at the same adult sectionals, provided they do not serve as an official for any of the championship events.

#### D. AGE CATEGORIES AND EXHIBITIONS

Per rule 2552, there shall be age categories for all singles free skate, emotional performance, lyrical pop/character/comedy and solo dance events (does not include pairs events, championship events or partnered dance events).

The age categories at the U.S. Adult Championships for free skate, emotional performance and lyrical pop/character/comedy events are as follows:

Class I: 21 years through 35 years
Class II: 36 years through 45 years
Class III: 46 years through 55 years
Class IV: 56 years through 65 years

Class V: 66 years and older

The age categories at the U.S. Adult Championships for solo pattern dance and solo free dance events are as follows:

Class I/II: 21 years through 45 years

Class III/IV/V: 46 years and older

All age classes will be combined in championship events at the adult sectional championships.

At the chief referee's discretion, age class events with fewer than six entries may be combined, after consultation with the national vice chair for adult competitions and the chair of the competitions committee.

After the close of registration, if an event with one skater/team cannot be combined with another age group and/or level, the event will be held as a single-entry event. Skaters/teams in single-entry events will receive the trophy or medal for their event and will receive the corresponding points for their club toward the team trophy, along with competition credit in the U.S. Figure Skating Lifetime Competitor Recognition Program.

A competition will be held if at least one eligible competitor appears at the start.

Proof of age is required for all events. Acceptable forms of documentation include birth certificate, passport, or similar proof. The LOC reserves the right to require additional information.

#### **E.** FOUR OR FEWER

When there are four or fewer competitors in an adult sectional qualifying event (championship junior-senior free skate, championship intermediate-novice free skate, championship adult gold free skate, championship adult silver free skate, championship masters pairs, championship adult partnered dance), competitors may progress directly to the U.S. Adult Championships. If there is only one competitor or team in an event, that person/team moves directly to the U.S. Adult Championships. See rule 2545. If, at the close of entries, there are four or fewer competitors registered for a qualifying event at an adult sectional championship, additional competitors from the same qualifying event in other sections shall be permitted to enter the U.S. Adult Championships to bring the number of competitors up to a maximum of 12 (or more if ties make it necessary). See rule 2546.

Competitors must state during the online registration process whether they will skate in their event

at the adult sectional championships if there are four or fewer within their section or 12 or fewer in all sections combined. **The statement is binding.** 

#### F. ENTRY FEES

All competitors entering the 2024 adult qualifying competition season must submit payment of the appropriate entry fee (amounts listed below) to U.S. Figure Skating. All competitors are required to pay both the entry fee into the qualifying competition season (for each event entered) and the administrative fee. All fees are nonrefundable, except as detailed in rule 2401.B.3 (see below).

## **U.S. Adult Championships Entry Fees**

Those competitors advancing in the championship events from the three adult sectional championships will have to submit an additional entry fee to compete in the same event at the 2024 U.S. Adult Championships. Instructions will be emailed to qualifying competitors after the adult sectional championships have concluded.

Per rule 2401.B.3, If an adult competitor enters a nonqualifying event at the U.S. Adult Championships and qualifies through the adult sectional championships to skate in the corresponding championship event, they will have the option to withdraw from the nonqualifying

event and receive a refund. In the case of qualifying in a championship partnered dance event, competitors may withdraw from either the partnered pattern dance or partnered free dance, but not both. Such withdrawal must occur within seven days of qualification at the adult sectional championship, or within seven days of being notified of qualification due to alternate status and withdrawal of a previously qualified skater.

Once entries have closed, entry fees are only refundable if the competition is not held, except as specified in rule 2401.B.3. There are no refunds for medical withdrawals. The chief referee reserves the right to combine, divide or cancel an event when necessary.

Your registration is not valid until all appropriate entry and administrative fees have been paid and all required forms have been completed online to U.S. Figure Skating. Please note, if payment has not successfully settled (NSF) by February 10, 2024, the skater will be withdrawn from the 2024 Adult Qualifying Season.

#### G. PAYMENT

Online payment via credit card is the ONLY accepted form of payment. Once entries have closed, there are no refunds or entry fees. Once entered, all withdrawals are considered final. A competitor may not re-enter even if the withdrawal occurs prior to the entry deadline of Feb. 1, 2024. Note, all transactions in EMS are subject to a 3% processing fee.

If you need to withdraw, you must send an email to the Events Department at <a href="mailto:events@usfigureskating.org">events@usfigureskating.org</a> with your name, U.S. Figure Skating membership number, event(s) in which you are entered and the competition from which you wish to withdraw.

#### **TECHNICAL DETAILS**

#### A.CONDUCT OF EVENTS

For the 2024 season, the international judging system (IJS) will be used for all championship singles events at the adult sectional championships. Championship adult partnered dance, championship solo dance and championship masters pairs events at the adult sectional championships will be judged with the 6.0 judging system.

At the U.S. Adult Figure Skating Championships, IJS will be used for the following events: all championship events with the exception of championship adult solo dance, <u>adult bronze free skate</u>, adult silver free skate, adult gold free skate, all masters-level free skate, <u>adult bronze pairs</u>, adult silver pairs, centennial pairs, adult gold pairs, masters pairs, and pre-gold partnered dance and higher. Lyrical pop/character/comedy and emotional performance events will be judged with the Showcase Component Judging System. All other nonqualifying events will be judged using the 6.0 judging system.

## **B.** AGE AND TEST QUALIFICATIONS

All age and test requirements can be found in the <u>2023-2024 U.S. Figure Skating Rulebook</u>. Adult singles test requirements can also be found on the U.S. Figure Skating website in the <u>Adult Singles Free Skating Event Eligibility Chart</u>. Adult showcase test requirements are found in the <u>Showcase Guidelines</u>.

#### C. TECHNICAL ELEMENTS / PROGRAM REQUIREMENTS

The well-balanced program charts for all levels and disciplines are posted on the <u>Adult Skating</u> <u>Rules and Resources Page</u> of the U.S. Figure Skating website.

For IJS information, reference the appropriate discipline section of the current ISU rules and the Adult Calling Clarification document, found on the U.S. Figure Skating website.

The lyrical pop/character/comedy showcase event contains programs that meet the definition of lyrical pop, character performance or comedic impressions programs in the <u>Showcase Guidelines</u>. Due to the combination of categories, props and lip-syncing are optional.

#### D. MUSIC AND PLANNED PROGRAM CONTENT (PPC)

<u>All competitors</u> entering the 2024 adult sectional championships and U.S. Adult Championships are required to submit the following items via their EMS Skater Portal one week prior to competition start date:

- Upload of each piece of competition music
- Music copyright information for all music
- Planned Program Content detailing the elements in the program (IJS ONLY)

Please note that you do not have to complete this at time of entry, although it is strongly encouraged. An athlete may update their skating program details at any time, after registration is complete, and up till one week prior to event start. Athletes will not be allowed to make any edits to their skating program one week prior to the start of the competition as this time is used for event organizers to download your information and prepare for the event. If any adjustments need to be made within one week of the event, they must be done onsite at the competition.

Finally, you will not be allowed to receive your credential at registration until U.S. Figure Skating and the local organizing committee have both received your skating program information. Questions? Email <u>productsupport@usfigureskating.org</u>

\*\*\*\*PAIRS AND DANCE TEAMS: When registering for a partnered event, only **one** member of the partnership will complete the event registration in EMS. Previously, the registering skater had sole control over the management of the registration. As of this season, the partner now has access to manage all the necessary competition items as well. Regardless of the partner being registered for other events, they will now have access to the competition portal for partnered event management, schedules and competition information.

#### MUSIC UPLOAD/SUBMISSION

For all qualifying competitions during the 2024 season, <u>online music submission through EMS</u> is the ONLY acceptable method to submit program music. The uploaded program music MUST conform to the following specifications:

• File Format: MP3

Maximum File Size: 12MB

Sound Quality: Set to Medium or High!

o Rate: 192kbps (minimum)

• Maximum Running time: Five (5) minutes

Maximum Leader/Trailer: The leader is the silence between the start of the track and
the actual start of the program music and the trailer is the silence between the end
of the music and track. The Music Committee prefers that neither are included on the
file but if necessary, are no more than two (2) seconds respectively.

#### **Copyright Information:**

U.S. Figure Skating, in compliance with BMI Licensing requirements, must collect the copyright information from each piece of music used in a skater's program. For assistance with this requirement, please click <u>here</u>.

#### **E.** OFFICIAL BULLETIN BOARD

The official bulletin board will contain any announcements or changes, and it is the responsibility of the competitors to check it often for official notices. Please refer to the local portion of the announcement for further information regarding the bulletin board.

#### F. SCHEDULE

A tentative schedule for the U.S. Adult Championships will be posted on the event website as soon as possible, estimated to be early March 2024. This schedule will not include event times, only the days on which each event will be held. A schedule will not be finalized until after the completion of the three adult sectional championships, in late March 2024. The tentative schedule is a preliminary schedule; therefore, skaters should NOT rely upon this schedule in making travel arrangements.

Skaters who enter more than one event assume the possibility of events being scheduled on the same day. The more events a skater enters, the higher this possibility is.

#### G. HEADPHONES

Earbuds and headphones of any kind will not be allowed on any practice sessions or warm-ups associated with the adult sectionals and adult championship competitions. If a skater is found to be wearing them on a practice session for these events they are subject to be disqualified for the event.

#### ADVANCEMENT TO THE U.S. ADULT CHAMPIONSHIPS

## **A.QUALIFIERS**

All competitors advancing to the 2024 U.S. Adult Championships will receive an email from U.S. Figure Skating within 48 hours of the conclusion of the adult sectional championships outlining the terms of advancement.

#### **B.** ALTERNATES

Skaters placing in fifth and sixth place at the adult sectional championships are not required to

provide any information to U.S. Figure Skating or the local organizing committee. All competitors are required to download the event announcement as they may be selected to compete up to 24 hours before their event. Response is required within 12 hours of receipt of the notice, or the next alternate will be contacted.

# 2024 MIDWESTERN ADULT SECTIONAL FIGURE SKATING CHAMPIONSHIPS

#### **GENERAL INFORMATION**

The 2024 MIDWESTERN Adult Sectional Figure Skating Championships will be held March 8-10, 2024 at the SCHEELS ICEPLEX located at 4300 N. Bobhalla Dr, Sioux Falls, SD 57107. The competition is sanctioned by U.S. Figure Skating and hosted by the Sioux Falls FSC.

The 2024 MIDWESTERN Adult Sectional Figure Skating Championships consist of the following qualifying championship events: championship masters junior-senior free skate, championship masters intermediate-novice free skate, championship adult gold free skate, championship adult silver free skate, championship masters pairs, and championship adult partnered dance. **Technical specifications and requirements for all qualifying championship events are detailed in the preceding 2024 Adult Qualifying Competition Season Technical Announcement portion of this document.** 

All other events are offered as a part of the 2024 MIDWESTERN Adult Sectional Championships and are considered nonqualifying and offered at the discretion of the Local Organizing Committee (LOC). Please refer to the Nonqualifying Specifications for the nonqualifying events being offered and other information specific to the nonqualifying events (located at the end of this document). Competitors will register through EMS for these nonqualifying events. And, for the purpose of fee calculation, registration for a qualifying event in the corresponding adult Sectional championship will count as a first event in this adult Sectional nonqualifying competition.

Plan on receiving these results a minimum of two hours after your event. Trophies will be awarded to 1<sup>st</sup>-4<sup>th</sup> place finishers and medals will be awarded for 5<sup>th</sup> and 6<sup>th</sup> place.

#### **OFFICIAL NOTICES:**

An official bulletin board will be maintained along the south wall of the mezzanine in the main rink (Furniture Mart Rink). It is the responsibility of each competitor, parent, and coach to check the bulletin board frequently for any schedule changes and/or additional information. Skaters are requested to arrive 45 minutes prior to the scheduled time of their event. A tentative schedule of events will be posted prior to the competition.

#### **TEST CREDIT**

Skaters that meet the requirements for test credit must request their test credit at registration prior to the start of the competitors event.

#### **TOSSIES**

No items of any kind are to be thrown on the ice. Violation of this rule may subject the offender to ejection from the arena. Baskets will be provided for spectators to use for athlete gifts.

## 2024 MIDWESTERN ADULT SECTIONAL NONQUALIFYING EVENT SPECIFICS

The 2024 MIDWESTERN Adult Sectional Nonqualifying Events will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the <u>current rulebook</u>, as well as any pertinent updates that have been posted on the U.S. Figure Skating <u>website</u>. Events are open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules and who are currently registered members of a U.S. Figure Skating member or collegiate club or who are individual members in accordance with the current rulebook. Please refer to the current rulebook for non-U.S. citizens.

#### **SERIES INFORMATION**

U.S. Figure Skating Adult Competition Series final events and awards will be a part of this competition.

#### NONQUALIFYING COMPETITION ELIGIBILITY/TEST LEVEL

**Test Level**: Competition level is the highest test passed as of the entry deadline in the discipline the skater is entering. Entrants may skate up one level above that for which they qualify, but they may not skate down in any event. Skaters may compete in as many categories/disciplines as qualified by their test level (or one above, but not both) and age, but may compete in only one event per category/discipline of competition. Competitors may enter both partnered and solo dance events.

**Nonqualifying Competition Age Restrictions/Requirements:** This competition is limited to athletes 18 and older as of the entry deadline.

#### Age classes for all free skate, emotional performance and lyrical pop/character/comedy events::

Young Adult: 18 years through 20 years

• Class I: 21 years through 35 years

Class II: 36 years through 45 years

• Class III: 46 years through 55 years

• Class IV: 56 years through 65 years

Class V: 66 years and older

Age classes for all solo free dance and solo pattern dance events:

- Young Adult/Class I/II: 18 years through 45 years
- Class III/IV/V: 46 years and older

All age classes may be divided or combined depending on the number of entries and at the discretion of the Chief Referee and/or the competition committee. Men and ladies will be combined in adult 1 through adult high beginner free skate events, and all levels of compulsory moves, solo pattern dance, solo free dance, jumps, spins and showcase events. In the adult pre-bronze and adult bronze free skate events, a single male or female competitor with no competitor of the same gender in another age class may choose to be combined with the opposite gender, skate an exhibition for first place, skate up to the next higher level (if this provides a competitor) or be issued a refund. Men and ladies will not be combined in adult silver and higher free skate events. Athletes in adult silver and higher free skate events with no competitor of the same gender in another age class will be offered the opportunity to skate an exhibition for first place, skate up to the next higher level (if this provides a competitor) or be issued a refund. The Chief Referee reserves the right to request proof of age.

#### **PARTNERED EVENTS:**

Only one partner will complete registration for the team. During the registration process, you will be asked to identify your partner and verify their test information. All music must meet the following criteria. If you have questions about what format you have, please contact your coach and get a new version of your music that meets the criteria listed below.

#### Music Criteria:

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
  - o This will be verified by the music chair and they may request you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. We prefer that there be NO leaders or trailers at all. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors must also bring a copy of their competition music on CD or digital copy (if you are accepting digital back up such as on a phone or memory stick) as a backup in case of technical difficulties and must be available rink side during the competition. Only CDs (standard CD-R format only) will be accepted for backups and must be clearly marked with the competitor's name, event and running time.

#### <u>PLANNED PROGRAM CONTENT (PPC)</u> - IJS EVENTS:

Competitors participating in IJS events are required to submit PPC in EMS no later than **February 19th 11:55pm ET**. After this date, skaters will be locked out of this feature in EMS and subject to a **\$25 late fee**. - ✓ Must be a current full member of U.S. Figure Skating either through a member club or as an individual member.
- √ If 18 years or older, must submit information for, proper payment of \$30 and successfully pass a background check.\*
  - The background check will be valid for two seasons, the one in which it was completed plus one additional.
- ✓ If 18 years or older, must complete annual SafeSport Training. \*
  - The training will be valid for 365 days from date of completion and there is no cost for the training/certification.
- ✓ Must complete the Professional Coach/Choreographer Coaching Education Requirement (CER) through the Professional Skaters Association (PSA).
- ✓ Must submit proof of general liability insurance with limits of \$1 million per occurrence/\$5 million aggregate.
- ✓ Must agree to the U.S. Figure Skating Code of Ethics. \*
- ✓ Must complete three waivers: 1) Assumption of Risk, Waiver and Release and Indemnification Agreement, 2) Medical Consent and 3) Name and Likeness Release and Consent Agreement. \*
- ✓ If attending a qualifying competition or traveling as a part of Team USA and/or International Selection Pool (ISP), must be a full member of the <u>Professional Skaters Association (PSA)</u>.

- ✓ Must be a current full member of U.S. Figure Skating either through a member club or as an individual member OR have a Learn to Skate USA instructor membership
