Bonnie is ordering medals and awards. Donations are still needed in concessions and hospitality room.

### **Coaches Meeting Update**

Karen had held a coaches meeting and opened discussion about future days/times ice may be contracted at the new rink opening fall 2014. The coaches in attendance stated they liked having LTS on Wednesdays. Karen announced that a new coach Amber Crew has been hired. She is from Windom, MN and has experience with hockey.

Coach Sarah and 3 SFFSC skaters will be attending this competition. Sarah will be covering the judging hours.

### **Stampede Exhibition**

On 4/5 (last home game), SFFSC will be performing an exhibition skate during the first intermission of the game. Karen will be utilizing 45 minutes of ice after the In-House Competition, 2:00 - 2:45, for a quick program rehearsal.

#### **Publicity**

It was suggested the "Hood" Magazine may be a good advertising tool for the Club in the future. It was decided to address this option in the summer.

### **Scheels Ice Plex Committee**

Patty reported that the Club will be charged tax on ice rentals. The Club is hoping to offer new programming for skaters will special needs through a possible grant

Patty contacted Sheila Thelen in Minneapolis who put her in touch with a well-known expert in jump harness installation. Through fundraising and grants, the Club is hoping to purchase one in the future. The architects at the future new rink needed specs for the harness so future installation may be possible and safety requirements will be met. That information was forwarded on to Ice Sports and will be utilized during the construction process.

Ice days/times options will be the first priority of business in the "brainstorming" committee Patty has formed. Programming will follow after careful thought about what works well and shouldn't be changed and what the Club may want to consider changing.

The next committee meeting will take place at Patty's home on 3/17/14 at 6:00pm. The Committee's suggestions will be presented to the board for approval at a later date.
